- Complaints received atleast 04 days before the meeting will only be considered in the meeting.
- Complaints regarding Administrative negligence or in efficiency in performing obligatory duties on part of officers / officials of SBCA may also be heard by the Public Hearing Committee and observation of the Chairman shall be forwarded to the Director Administration.
- Complaint Section, SBCA or ABAD may also refer any complaint to the committee which could not be resolved at their end due to any reason.
- Call letters will also be issued to the Complainants and concerned Builder / Developer to attend the hearing along with the record / files.
- Matters will be heard and resolved in accordance with the terms and conditions
 of NOC for Sale & Advertisement and approved building plans and provisions of
 KB&TPR. However in case of mutual consent on some issues between
 complainant and Builder / Developer, Committee may decide the matter
 amicably.
- Matters subjudiced before Court of Law shall not be placed before the committee.
 However the complaints pending before Ombudsman, NAB or other forums may be heard by the committee and decision / settlement should be communicated to the concerned agency.
- Decisions / Settlements made by the committee during each meeting will be submitted for approval of DG, SBCA whose decision will be final and binding on all parties.
